Procedure

- 1. Dry blend aloe vera powder, citric acid, stevia extract, vitamin premix, and Aqualon™ 9M31F cellulose gum.
- 2. In a separate vessel, combine lime juice concentrate, agave nectar, spearmint flavor, lime flavor, and water.
- 3. Using overhead stirrer, slowly add dry ingredients into liquids with continuous mixing for 20-30 minutes. This ensures full hydration of the cellulose gum.
- 4. Pasteurize using Microthermics™ UHT/HTST machine at 1 liter/min and 105°C (220°F).
- 5. Hot-fill into PET bottles and immediately place into ice water bath to cool below 43°C (110°F). Serve cold.
